U/S 21(2)-All persons interested in the land to appear personally or by agent or advocate before the Collector at DC's office, Shillong not being less than 30(thirty) days and more than 6(six) month after the date of publication of the notice, and to state the nature of their respective interest in the land and the amount and particulars of their claims to compensation for such interest, their claims to rehabilitation and resettlement along with their objections, if any to the measurement made under section 20.

U/S 22(1)- Any such person may also require to make or deliver to the Collector at DC's office, Shillong not being less than 30(thirty) days, a statement containing the name of every other person possessing any interest in the land or any part thereof as co-proprietor, sub-proprietor, mortgagee, tenant or otherwise and of the nature of such interest, and of the rents and profit, if any, received or receivable on account thereof for three years next preceding the date of the statement.
